From The Pastor

To all the saints at Good Shepherd,

Now that the Christian community has celebrated the birth of its Lord and has also joined the rest of the world in welcoming a new year, we can finally say the “holiday season” is over. That being the case it is now time to look forward to what is next on the calendar; a quick check of which informs us that Easter will be celebrated on April 8, which as I write this article on January 23, is only 76 days away.

With that in mind let us also be mindful that between now and Easter the Church will observe the six week Lenten season which this year extends between **Ash Wednesday, February 22 and Saturday of Holy Week, April 7**. Though the actual total number of days between the fore mentioned dates is 46, only 40 of them are counted days of Lent. This is because Sundays are excluded and are identified as being *in* Lent. The reason I share this distinction is because I want to draw attention to the number 40, which is used numerous times in the Bible. One such occasion occurs on the first Sunday of each year when the appointed gospel reading tells of Jesus being in the wilderness for 40 days being tempted by the devil. (Matthew 4: 1-11, Mark 1:9-15, Luke 4: 1-13)

One website provided this information regarding the significance of the number 40: “*A 40-something time period, whether days, months or years, is ALWAYS a period of testing, trial, probation, or chastisement (but not judgment) and ends with a period of restoration, revival or renewal.*” In other words there is provided a period of time, when through reflection and reevaluation, and prayer, one may be led to make some adjustment in lifestyle which is positive and beneficial. As one psychologist noted it generally takes six weeks (42 days) to adopt some new habit whether it be in terms of behavior or in thinking. So if you truly intentionally want to replace something old with something new you may find Lent the ideal time to make that happen. Don’t try to change everything and in so doing become discouraged. Focus on one thing in particular and allow God’s spirit to be your strength as you move through forty days of building a better you and which will make resurrection a more meaningful word come Easter.

This year, Ash Wednesday, which marks the beginning of the Lenten season, will be February 22. That evening there will be a “soup supper” at 6:00 pm followed by a Vesper service at 7:00 pm which will include the Imposition of Ashes.

On the following six Lenten Wednesdays there will be offered the opportunity to participate in a series of small group discussions using the resource booklet “Caring and Community: Perspectives from Ephesians”, which will be provided for each participant. To assure as much participation as possible, groups may meet during the day (1:00 pm) or in the evening (7:00 pm). In either case at least six participants are necessary to assure maximum benefit from the discussions. As you consider taking part in this helpful program you may find the following information taken from the course booklet’s introduction helpful in encouraging your participation.

“The relationship of faith to daily life is a constant concern for the Christian Community. Caring and Community is a resource to help you explore this concern. The six chapter themes will help you seek out the biblical truth contained in the Epistle to the Ephesians and find ways to relate them to the daily walk of faith. Caring and Community asks questions to stimulate conversation and encourage the exchange of not only thoughts and ideas, but also feelings and sentimentsAs you study together, your growth and effectiveness will come from God’s grace, not from your own ingenuity, gimmicks, or cleverness. God’s presence in your prayers, sharing, conversation, and study will give you the power to grow and change. . . .God has created us for fellowship and relationship with one another, God, self, and nature. God in Christ has established a gracious commitment of caring, which stands as a model of our caring for one another. As each person is open to the leading of God’s Spirit, the insights from God’s Word, and the peace of God’s presence, life will change and work better because God is at work in us enabling us to both “will and work for his good pleasure”. . . .As you study together, the resource will help provide the setting in which community can be created through open, living, and trusting relationships.”

In the midst of a very challenging world it is important that we are not alone. We need each other. Make this your Lenten discipline. Sign-up sheets are available in the entrance way.

PASTOR’S REPORT: Pastor Jack is signing a contract with Singing Boys of PA for a concert Saturday, April 28, 7PM. Good Shepherd must pay a \$1K fee for 90 minute program.

LOGISTICS

- ⤴ :The choir will arrive at Good Shepherd at 3PM for setup.
- ⤴ Debbie agreed to prepare light meal for 15 boy singers and several adults.

- \$140 was sent to ELCA Good Gifts "Buck a Chick" Program
 - 140 chicks were purchased and sent to help families in need
- 40 Children attended VBS.
- The Children did a GREAT job with the annual Christmas Pageant.

Fellowship Committee Report – Debbie Blackburn

- Thanks to the good people of Good Shepherd in supporting the fellowship events in the Church
- Continued our old traditions such as the Easter Breakfast and the Family Christmas Party
- Thanks to all who contributed food and talent.

Stewardship Committee Report – Karl Torjussen

- 2011 Stewardship program was very successful
- Temple Talks were held and we had a dedicated sermon in November to Stewardship
- We emphasized Mission support
- We need continued support from the congregation

Property Committee Report – Steve Miller

- Thanks to all who contributed their time and talent
- Successful drive to repair the roof leaks
- Re inform everyone on importance of keeping thermostats to 50 degrees when no one is in church

Social Ministry Report – Mike Carp

SOCIAL MINISTRY and Environmental Tithing

The by-laws of Good Shepherd state that the purpose of the Social Ministry committee “shall be to extend Christian compassion and helpfulness to the ill, the aged, the orphaned, the underprivileged, the imprisoned and, in general, to persons of all ages in need of aid in body or soul”. To address this mission our congregation through the years has been supporting groups such as Lunchbreak , the Kitchen at Saint Mark's in Keansburg, Family Promise, World Hunger Appeal and the Community Outreach Group, Inc. (COG).

Today well over a billion people in the world are deprived of what they need to meet their basic needs. Many lack clean water, adequate sanitation, housing or health services. In the near term supporting agencies responding to immediate needs is very important but in the long term meeting today’s and future generations need for food, clothing and shelter requires a sound environment.

The ELCA’s social statement on Caring for Creation states that action to counter degradation, especially within this decade, is essential to the future of our children and our children’s children. As members of the church we are asked to commit ourselves to personal life styles that contribute to the health of the environment – to consider tithing environmentally, e.g. producing ten percent less in waste, consuming ten percent less in non-renewable resources.

Environmental tithing also entails giving time to learn about environmental problems and to work with others toward solutions. The issue of global warming and actions to address it, questions about extracting natural gas through hydraulic fracturing and water rights are often news items getting national and local attention.

I would appreciate learning of other members of Good Shepherd who are interested in discussing/suggesting ways we as individuals or a congregation can work together to tithé environmentally.

As a starter tithing step towards lowering air pollution by toxic emissions--

STOP IDLING YOUR CAR!!

- 10 second of idling uses more fuel than turning the engine on and off?
- State law prohibits idling for more than 3 minutes?

The Social Ministry Committee has already begun planning "outreach" activities for the new year. For example, the SOUPERBOWL OF CARING is scheduled for the last two Sundays of January and the first two Sundays of February to coincide with the National Football League's annual extravaganza, the Super Bowl. The difference in spelling between the two events underscores the goal of the SOUPERBOWL, which will collect funds to help support local food kitchens and food banks.

Various other projects will continue through Lent as the parish takes part in the Evangelical Lutheran Church in America's WORLD HUNGER DRIVE. As spring and summer arrive, LUTHERAN SOCIAL MINISTRIES, INTERFAITH NEIGHBORS and LOVE INC will be promoted as well as SHOP FOR A CAUSE and the COG HOUSEHOLD ITEMS COLLECTION. In the fall we will turn to other, ongoing projects such as the RED BANK CROP WALK and we will end the year with a special CHRISTMAS PROJECT spearheaded, as always, by the Sunday Church School.

Special, unexpected disaster appeals will also be brought to the attention of the congregation, if and when they arise, and ongoing programs, such as SAINT MARK'S SPONSORS and FOOD COLLECTION and LUNCH BREAK COFFEE COLLECTION will continue throughout the year.

In 2011, with some assistance from Thrivent, the Good Shepherd congregation provided over \$19,000 to "outreach", a larger sum than in 2010. The goal for 2012, of course, is to give even more. How the congregation is able to "reach out", of course, depends on the response of every member.

FOOD PANTRIES STRUGGLE AFTER HOLIDAY GIVING

In the Sunday January 15 edition of the "Asbury Park Press", staff writer Paula Scully reported that the holiday "good will" to the local soup kitchens and food pantries from local residents began evaporating sometime after the new year arrived. The continuing weak economy and reductions in federal food allotments could make this an even more serious problem for local, needy families. Fortunately, a part of the shortage is being filled by help from some major supermarket chains, local churches and organizations and private citizens.

At the FoodBank of Monmouth and Ocean Counties, based in Neptune, federal food allocations were down 32% for the first six months of 2011, according to the organization's director. "Our agencies are seeing an increase in the number of people coming in and asking for food", she added. Somewhat offsetting this reduction from the government are donations from major chains, including BJ's, Costco, Acme, Trader Joe's, Sam's Club and Walmart. Donated food is up 35% while federal allocations dropped by 32%, thereby keeping the supply available. The Tuckerton Food Pantry reports that they must spend about \$500 a month at various super markets to offset the decreased allotments it receives from the FoodBank of Monmouth and Ocean Counties.

Gwen Love, executive director of Lunch Break, which has served Red Bank for more than 25 years, said they have seen an increase in the demand for all their services, including the food pantry and the lunch program. "In

December 2011 we served 1,151 families, compared to 659 families in December 2010. The number of families almost doubled in just one year." "When I came here in October 2008, we served 80 families", she said. "We have people who have jobs, but it's so expensive to pay for everything..... Which bill should they pay first?" "But, it's not all 'Gloom and Doom'. It's about people in the community helping others".

Doreen MInutella, co-director of Saint Mark's food Kitchen and Pantry in Keansburg, said, "Each month is a challenge. Even if we get enough vegetables, fruit and pasta, we are always short of meat. We try to give them a little bit of meat and meat has to be bought at some local store and that takes money, money that has been harder and harder to come by."

Ask yourself - How can I help to feed my hungry neighbors in Monmouth County? Good Shepherd Church has a variety of ways you can help:

1. Bring food to church each month for Saint Mark's Pantry.
2. Add your name to the "Saint Mark's Sponsors" list.
3. Write a check for any of the food pantrys in this area.
4. Bring a can of coffee for Lunch Break.
5. Write a check for the FoodBank of Monmouth and Ocean Counties.
6. Telephone any of the local food kitchens and volunteer to help.

As Gwen Love of Lunch Break put it, "It's about members of the community helping others."

HOW TO MAKE A SPECIAL GIFT TO THE CHURCH

During the past year there has been a problem identifying and recording special gifts to the church by members of the parish. For example, money given to the Memorial and Thanksgiving Fund and designated for a specific fund (World Hunger, St. Mark's Food Pantry, Malaria, SouperBowl of Caring etc.) ended up in the general fund and was used for day-to-day expenses. Those who recognized that their special gifts to the church were not properly assigned may have been able to notify the Treasurer. In most cases, however, the donor never realized the problem and, therefore, the designated fund was never increased by the proper amount.

In order to insure that all special gifts are assigned to the fund for which they were originally designated, donors can take a few easy steps:

1. Write an individual check or use separate funds for your special gifts.
2. Use a separate envelope for your special gifts. Do not use your regular, weekly offering envelopes. Special Social Ministry envelopes are now available in the wooden racks by the main door.
3. Mark the separate envelope for your special gifts with the name of the fund to which you want the gifts assigned (World Hunger, St. Mark's Food Pantry, Malaria, SouperBowl of Caring etc.) along with your name and envelope number.

The volunteers who count the weekly offering will be alerted that your envelope contains a gift for a special fund only if you mark your envelope accordingly. In the future, please follow these simple directions to make your special gifts to or through the church, including gifts to the Memorial and Thanksgiving Fund.
